- i. establish friendly and loyal co-operation between all members of the Company (hereinafter called "**Members**") for the benefit of the sport of gymnastics;
- ii. strive to ensure that no racial, religious, political or other kind of discrimination be allowed in the sport of gymnastics, and take all practicable measures to stop such discrimination;
- iii. strive to secure that there shall be no hindrance to the participation of any country or individual in gymnastics competitions on racial, religious or political grounds, and to ensure that there be no such hindrance in gymnastics meetings over which the Company has control;
- iv. compile articles and regulations governing national competitions for men and women of all ages and abilities in gymnastics;
- v. decide any dispute that may arise between Members if called upon to do so;

vi. enforce through its rules and regulations, the Irish Anti-Doping Rules as published by the Irish Sports Council as amended from time to time;

vii. co-operate and comply with the rules and regulations of the Federation Internationale De Gymnastique (FIG) and co-operate with such other sporting associations as the Board of Control shall deem appropriate from time to time;

viii. promote, through its rules and regulations, adherence to the Code of Ethics and Good Practice for Children's Sport as published by the relevant regulatory authorities in Ireland and as amended from time to time; and

ix. promote, through its rules and regulations, adherence to the Child Protection' Guidelines' issued by the relevant regulatory authorities in Ireland and as amended from time to time;

b)c) In furtherance of the above objects, but not otherwise, the Company shall have the following powers of the company which it may exercise at its discretion;

(i) to carry on any business which may be seen by the Company as capable of being conveniently carried on in connection with the above main objects or calculated directly or indirectly to enhance the value of or render profitable any of the Company's property, rights or interests;

(ii) To make and publish where necessary, rules and regulations for the government of the sports set out at (a) above.

4. The income and property of the ~~association~~Company shall be applied solely towards the promotion of its main object(s) as set forth in this Constitution. No portion of the ~~association's~~Company's income and property shall be paid or transferred directly or indirectly by way of dividend, bonus or otherwise howsoever by the way of profit, to the members of the ~~association~~Company. No officer shall be appointed to any office of the ~~association~~Company paid by salaries or fees, or receive any remuneration or other benefit in money or money's worth from the ~~association~~Company. However, nothing shall prevent any payment in good faith by the ~~association~~Company of:

- a) Reasonable and proper remuneration to any member of the ~~association~~Company (not being an Officer) for any services rendered to the ~~association~~Company;
- b) Interest at a rate not exceeding 5% per annum on money lent by Officers or other members of the ~~association~~Company to the ~~association~~Company;
- c) Reasonable and proper rent for premises demised and let by any member of the ~~association~~Company (including an Officer) to the ~~association~~Company;

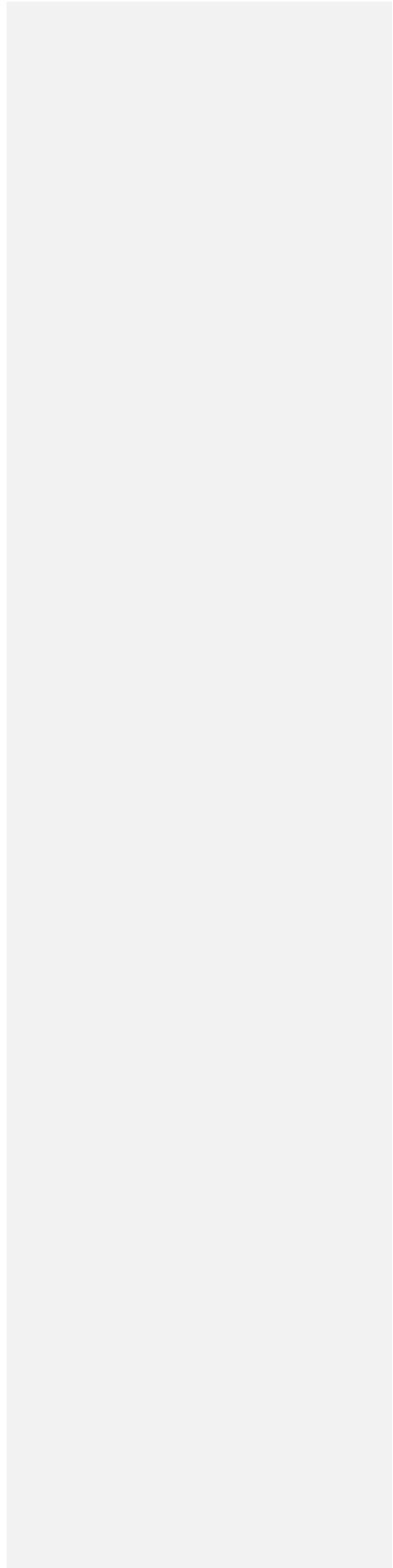

In the event of the Company being wound up every member who is a member of the Company at that time or who was a member within one year of that undertakes to contribute to the assets of the [companyCompany](#) for the payment of the debts and liabilities thereof which were contracted prior to the date s/he ceased to be a member thereof and the costs, charges and expenses of winding up and for the adjustment of the rights and of the contributor among themselves such amount as may be required not to exceed the sum of 5 Euros.
7. If upon the winding up or dissolution of the [associationCompany](#) there remains, after the satisfaction of all its debts and liabilities, and property whatsoever, it shall not be paid to or distributed among the members of the [associationCompany](#). Instead, such property shall be given or transferred to some other institution or institutions having main objects similar to the main objects of the [associationCompany](#). The institution or institutions to which the property is to be given or transferred shall prohibit the distribution of its or their income and property among its or their members to an extent at least as great as is imposed on the [associationCompany](#) under or by virtue of Clause 4 hereof Members of the [associationCompany](#) shall select the relevant institution or institutions at or before the time of dissolution, and if and so far as effect cannot be given to such provisions, then the property shall be given or transferred to some charitable object.
8. No addition, alteration or amendment shall be made to or in the provisions of this constitution for the time being in force unless the same shall have been previously approved in writing by the Revenue Commissioners.
9. Annual audited accounts shall be kept and made available to the Revenue Commissioners on request.

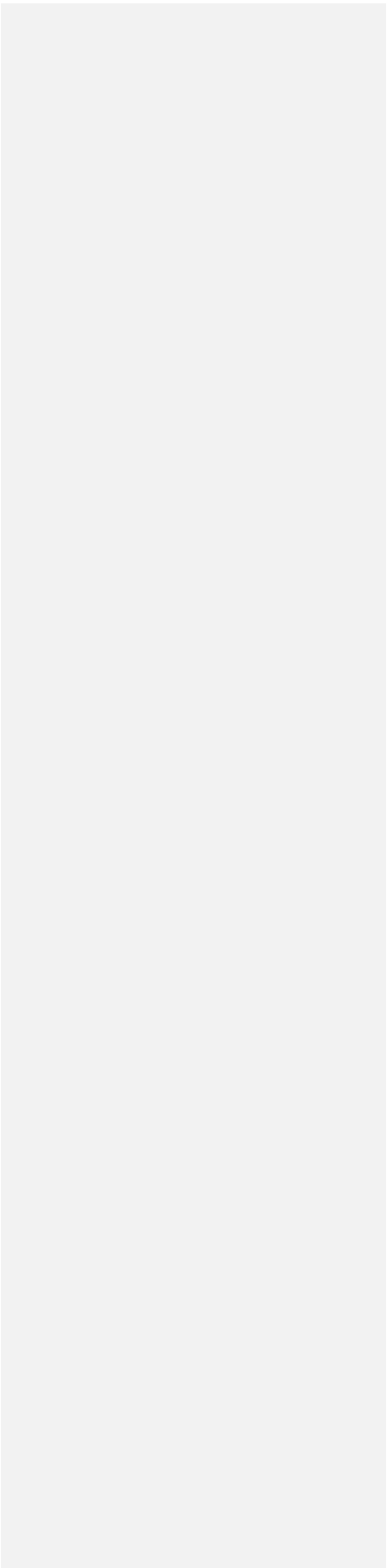

ARTICLES OF ASSOCIATION

OF

IRISH GYMNASTICS LIMITED

1. Interpretation

In these Articles the "Law" means the Laws of the Republic of Ireland and anything in these Articles, which is incompatible therewith are amended thereby so that they are in conformity therewith at all times.

- a) In these Articles the following words and expressions shall have the following meanings unless there is something in the subject matter or context inconsistent therewith:

"The Act" is means the Companies Act/Acts, 1963 as amended from time to time.

"Acts" means the Companies Acts 1963 – 2009 as amended from time to time.

"Adult Members" means any individual over the age of eighteen that has been accepted into membership of the Company as an Adult Member in accordance with the Rules and whose membership has not either lapsed or been terminated and who has paid a fee to the Company in accordance with the Rules.

"Affiliate" means a person or entity including a club, regional/Provincial association or national association accepted as an affiliate in accordance with Article "219" hereof established by or approved by the Company.

"Association" means the Company, Irish Gymnastics Limited which has been formed by merger of Irish Amateur Gymnastics Association Limited and Irish Sports Aerobatics

"Committee" means any committee or sub-committee established by the Board of Control.

"Complaints and Disciplinary Rules and Procedures" means the Complaints and Disciplinary Rules and Procedures adopted by the Board of Control as amended from time to time.

"Complaints and Disciplinary Committee" means the committee established by the Board of Control to oversee the Complaints and Disciplinary Rules and Procedures.

'Connacht Branch' means the branch of the Company which is made up of Clubs located in the counties of Galway, Leitrim, Longford, Mayo, Roscommon and Sligo;

"Ethics and Welfare Guidelines" means any codes of ethics, child welfare guidelines, protections or good practices as the Company may adopt or establish and amend from time to time. An up to date copy of all such documentation will be maintained in the Appendices to the Rules.

"FIG" means the Federation Internationale de Gymnastique.

"Law" means the Laws of the Republic of Ireland and anything in these Articles, which is incompatible therewith are amended thereby so that they are in conformity therewith at all times.

'Leinster Branch' means the branch of the Company which is made up of Clubs located in the counties of Carlow, Dublin, Kildare, Kilkenny, Laois, Louth, Meath, Offaly, Westmeath, Wexford and Wicklow;

"Joint Members" means any cohabiting couple over the ages of eighteen that have been accepted into membership of the Company as a Joint Member in accordance with the Rules and whose membership has not either lapsed or been terminated and who has paid a fee to the Company in accordance with the Rules.

"Juvenile" means, in relation to any particular day, a person who will be under the age of 18 as at that date;

"Member" means any person who is admitted to membership of the Company in accordance with these Articles and the Rules and whose name is entered on the register of Members of the Company and "Membership" shall be construed accordingly.

'Munster Branch' means the branch of the Company which is made up of Clubs located in the counties of Clare, Cork, Kerry, Limerick, Tipperary and Waterford;

"Non-Voting Members" means any person who is admitted to membership of the Company other than as a Joint Member, Adult Member or Student Member in accordance with the Rules and whose membership has not either lapsed or been terminated and who has paid a fee to the Company in accordance with the Rules.

"Office" means the Registered Office for the time being of the Company.

"Officers" means the 12 officers of the Board of Control set out in Article 45.

"Other Rules" means any articles, bye-laws, conditions, constitution, laws, orders, procedures, regulations, rules, terms of reference or other provisions (by whatever name called) providing for or regulating any aspect of the affairs of the Company (other than these Articles, the Rules, and the Rules of Competition) or of FIG in force from time to time;

"Provinces" means the Connacht Branch, Leinster Branch, Munster Branch and Ulster Branch and "Province" means any one of them.

"Provincial Representative" means the representative of each of the Provinces on the Board of Control.

"Rules" means the uniform rules and regulations governing the operation and management of the Sport in Ireland drawn up by the Board of Control and as amended from time to time by the Board of Control;

"Rules of Competition" means the FIG rules on competition as in force from time to time, as amended from time to time.

"Secretary" shall mean any person appointed to perform the duties of the Company Secretary.

"Office" means the Registered Office for the time being of the Company.

"the seal" shall mean the common seal of the Company.

"the Sport" means the sport of gymnastics in all its forms which includes inter alia Women's Artistic, Men's Artistic, Rhythmic, Trampoline, Acrobatic, Tumbling, Gymnastics For All, Aerobic, Special Needs and all other related disciplines.

"Student Members" means any individual over the age of eighteen that has been accepted into membership of the Company as a Student Member in accordance with the Rules and whose membership has not either lapsed or been terminated and who has paid a fee to the Company in accordance with the Rules.

"Ulster Branch" means the branch of the Company which is made up of Clubs located in the counties of Antrim, Armagh, Cavan, Derry, Donegal, Down, Fermanagh, Monaghan and Tyrone;

82. Candidates wishing to stand for election as an Officer or for any office under these Articles where election at the Company AGM is required, must receive the nomination of at least two (2) Clubs in their Province, one of which must be their own. In the case of Clubs, nominations must be approved at a committee meeting of the relevant Club which must be held in advance of the closing date for receipt of nominations by the Company.

83. The names of nominees for election must be notified to the Secretary no later than 28 Clear Days prior to the date of the Company AGM

#### **PROVINCIAL MANAGEMENT COMMITTEES AND PROVINCIAL ANNUAL GENERAL MEETINGS**

84. There shall be a branch of the Company in each of the Provinces which shall be known as the Connacht Branch, Leinster Branch, Munster Branch and Ulster Branch of Irish Gymnastics (together the "**Provinces**"). Subject to the provisions of these Articles, the powers and functions of the Provinces shall be as set out in the Rules.

85. Each Club shall be a member of the Province in which it is located.

86. An AGM of all Clubs located in each Province (a "**Provincial AGM**") shall elect once every year a committee which shall be known as a Provincial Management Committee (a "**Provincial Management Committee**"). Subject to the provisions of these Articles, representation on, composition, powers and functions of, terms of reference for and procedures of the Provincial Management Committees shall be as set out in the Rules.

87. The Board of Control shall, with the assistance of each Provincial Management Committee, convene Provincial AGMs for each Province to be held at least one (1) month prior to the Company AGM. Each Provincial AGM shall be co-ordinated and managed in accordance with the instructions of the Board of Control and shall be presided over by the President.

88. At such Provincial AGM, there shall be elected (i) the Provincial Management Committee (iv) a Provincial Representative and (vi) (if required and pre-approved by the Board) Provincial sub-committees to assist the Provincial Management Committee in the performance of its duties.

89. The members of the Provincial Management Committees shall hold office in accordance with the following terms:

- a) the members of a Provincial Management Committee shall hold office from the conclusion of the next Company AGM after the Provincial AGM at which they are elected until the conclusion of the next Company AGM

#### ~~19. Winding Up:~~

##### DISCIPLINARY MATTERS

101. The Board of Control shall have the power to discipline any Member, Club, Province or other Affiliate when it is satisfied there has been any breach of these Articles, Rules, Bye-Laws, the Rules of Competition or any Other Rules of the

Company or the equivalent constitutional provisions of its affiliated bodies, or where there has been conduct likely to bring the Company or the Sport into disrepute.

102. The Board of Control may, without limitation, suspend Membership of any person or body, impose fines on, remove recognition of titles won or records achieved by, caution or censure any such person or body.

103. The Board of Control may suspend the Membership of any person or body pending the outcome of any investigation process.

104. The Board of Control may delegate the exercise of its disciplinary functions to specific sub-committees of the Board of Control, created with specific remits and devolved decision making authorities, subject to final approval by the Board of Control.

105. In cases where doping is alleged or suspected or is or may be an issue, the Company shall follow the procedures and rules referred to Article 106 to Article 109. Subject to those procedures and rules, the Board of Control may establish an appeals and/or review procedure for such cases.

106. The Board of Control shall adopt such Other Rules as it deems necessary to govern its complaints and disciplinary procedures against any Member, Club, Province, or Affiliate.

#### **ANTI-DOPING RULES**

107. The anti-doping rules of the Company are the Irish Anti-Doping Rules published by the Irish Sports Council and as amended from time to time by the Irish Sports Council. The Company accepts the right of FIG, the Irish Sports Council, the Olympic Council of Ireland, or duly authorised representatives of such bodies, to dope test, in accordance with law, any Members both in-competition and out of competition (i.e. unannounced testing).

108. It shall be a fundamental condition of Membership, in addition to any other provisions concerning membership and the various categories of membership as laid down in these Articles, that, subject to Article 108, Members submit to and comply with any dope testing by the Company or any of the bodies referred to in Article 106.

109. In the case of a Juvenile who is asked to be subject to dope testing, the prior written consent of his parent or guardian must be given either via the initial membership process at Club level, or at selection for competition or through competition entry forms.

#### WINDING UP

110. The Company may be wound up in the manner provided for by the Companies Acts or any statutory modification made thereto for the time being in force and in accordance with the Memorandum of Association.
